Churchwardens' Report

The year started off with the usual exciting Statistics for Mission. It showed we had a worshipping community of 64 people. Easter had an attendance of 59 people with the Christmas figures showing a total attendance of 69 people attending which was a great improvement on the 23 from the previous year after the pandemic!!

Early in the year it became obvious that the hatch covers in the Tower were in need of replacement. Dougie Hill very kindly came quickly and replaced one to stop the bellringers disappearing into the space beneath. The other hatch needed more serious attention which Nick Harris replaced for us in July.

In February storm Eunice decided to rip through and removed several tiles on the North side of the roof and in the valley. Brian Cousins came and repaired everything for us. He is a marvellous man who climbs around on the roof quite happily and keeps us free from leaves and in good repair.

It was great to be able to hold again the usual events in Holy Week. Palm Sunday took place as usual with a wonderful rendition of Stainer's Crucifixion, thanks to Nick Gardiner and his choir, in the evening. We could hold the special Holy Communion service and Watch on Maundy Thursday. On Good Friday we returned to join with our Methodist friends for reflection, a walk of witness and hot cross buns followed by an Hour at the Foot of the Cross. It was good to be able to celebrate Easter Sunday with packets of seeds from Rev Jane outside the gate for people to take away.

The beginning of June we celebrated the Queen's Platinum Jubilee with activities for the children with tea and cake, followed by a Civic Service on the Sunday.

On the evening of Saturday18th June, after a lot of wind, an enormous branch broke away from the weeping lime tree and landed in the graveyard. Fortunately only causing serious damage to one grave. After a road closure and the arrival of an enormous crane the offending branch was removed and cut up.

The following Wednesday a sizeable fall of plaster from the ceiling on the south side of the church meant the aisle had to be closed off. Thanks, again, to Brian Cousins scaffolding arrived and within 3 weeks it was all repaired.

The Archdeacon's visitation took place again by Zoom in July.

In September we welcomed the arrival of Peter and Elizabeth Burren who have joined us as curates. Their help and support is proving invaluable.

Our Harvest Festival took place in October and the churchwardens sent out the Harvest Appeal letter which raised £4975 towards the maintenance of the church.

Remembrance went ahead with changes to the usual routine. This was appreciated by some but many felt the church connection was missing. We extend our grateful thanks to Rosy Plumb and Helen Boyd, and their team, for all they do to make the All Souls remembrance service a special and moving occasion.

During the Autumn we started to have problems with the boiler refusing to turn itself on again in the morning. Some days it co-operates but more often it doesn't, leaving the church (and congregation!!) feeling very cold. The PCC requested advice from a heating company who have given us a report and suggestions for moving forwards. The end result to all of this will appear in next years report!!

Christmas started off with a well-attended Community Carol Service with enjoyable refreshments beforehand. The following week we had a Living Crib and Christingle at the back of the Old Commercial with mulled wine, mince pies and carol singing.

The churchwardens owe a debt of gratitude to all those groups of people who keep the church alive - the members of the PCC – the Sacristy ladies who have everything ready for the Holy Communion services and who keep the linen and silverware in pristine condition – Fran Edwards and Valerie Ridgway who deliver plants and flowers to those who are unwell in the village – the Open the Book team who have kept in contact with the primary school and who have now started visiting again – the Stewards who help us run the church every Sunday – Mike and Jeff who do such great work in saving us a small fortune doing fabric repairs and who wind the clock every week and keep it in good time – the wonderful tea ladies – the flower ladies who make the church look so bright and inspiring - the bellringers who make such a joyful sound on a Sunday morning – the fundraising team who raise such invaluable funds for us - and especially Nick Gardiner who is always there to provide music and who is bringing the choir back together again.

The churchwardens were saddened to hear that Rev Jane Frost and Richard are leaving us. We would like to thank them both for all they have given to the Team during what has been a difficult 4 years. We wish Rev Jane well in her role as Associate Minister in the Totnes Team Ministry.

Reports from Church Organisations

Bellringing

Bellringing has been buoyant in 2022. There are 14 people who ring more-or-less regularly, including one beginner in training, and the standard has generally been very good. There have been 6 visits from ringers from other churches. Highlights have included a quarter peal of 1260 Grandsire Doubles on 16th December, with Roger Avery (Tower Captain) on the tenor and his daughter Rachel (who normally rings at Inverness Cathedral) on the treble, and the Association of Devonshire Ringers 6-bell competition, held here on 15th October. It is particularly gratifying that we were able to ring for services on Christmas Eve and Christmas Day.

Choir

Although the Choir was not back to regular Sunday morning singing during 2022, it did manage to regroup about a dozen times. These ranged from the major religious festivals to more localised occasions and activities.

We began with two services at Eastertide: Maundy Thursday and Easter Sunday. In June there was a special Civic Service to mark the Queen's Platinum Jubilee. Three months later we sang at the solemn Service of Commemoration following Her Majesty's death. In between these two occasions we went to St. Peter's Church in Shaldon for a special Haldon Team Songs of Praise. It was nice to join in, once again, with other singers and organists from the area.

The autumn season saw us back in Bishopsteignton, singing first at the Harvest Festival service and secondly at the funeral of Elizabeth Mitchell.

December saw a flurry of musical activity in our church, Luton church and other local venues. In our church we sang at the Carol service and at the 'Midnight in Bethlehem' service on Christmas Eve .

We returned to Luton for their Carol service - the first time since the pandemic. In addition we did some carol singing in our village : a lovely morning at Bishopsteignton House and a jolly evening in the Old Commercial Inn, where we raised £25.00 for 'Save the Children.'

We are a small, but very friendly choir. We are keen to expand and would welcome enquiries from anyone interested in joining us.

Structure, governance and management

The PCC comprises ex-officio, elected and co-opted members in accordance with The Church Representation Rules and operates under the Parochial Church Council Powers Measure. It is a *body corporate* established by the Church of England. A 3 year term of office applies to elected members. It is a charity excepted from registration with the Charity Commission.

All church attendees are encouraged to register on the Church Electoral Roll and stand for election to the PCC.

Safeguarding

The Parochial Church Council has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 (duty to have due regard to House of Bishops' guidance on safeguarding children and vulnerable adults). A copy of the church's Safeguarding Policy is displayed on the Notice Board.

Committees

The Church Maintenance Committee, with The Church Architects, Benjamin and Beauchamp, manages the major works required to the church. This committee reports directly to the PCC.

Objectives and activities

The Parochial Church Council (PCC) is responsible for co-operating with the Team Rector and the Team Vicar in promoting, within the ecclesiastical Parish, the mission of the Church, pastoral and ecumenical.

Annual Parochial Church Council Safeguarding Report for 2022

Thank you for helping the Haldon Mission Community in its efforts to provide a safe worshiping community for parishioners, clergy and visitors to our churches.

We continue to strive for training compliance so that our trustees (PCC Members) and our worship leaders (i.e., organists) can lead us with confidence knowing that they have all the Safeguarding Awareness and tools to do so.

We are safely recruiting church and independent workers (administrator) by using the guidance provided to us in the Parish Safeguarding Handbook. This includes obtaining DBS checks and managing recruitment and induction training.

The Parish Dashboard helps us to generate and maintain policies and processes to assist in our safeguarding mission. The newly added Safeguarding Hubs are an extension of the dashboard and its primary function is to assist parishes to meet the requirements of Safer Recruitment and People Management. Help is needed with the input of data to the hub for your parish. Please let me know if you would be prepared to help with this online activity.

As a community we have been involved in 3 significant outreach activities this past 6-12 months. These include the Open the Book School visits in Shaldon and Bishopsteignton and a Messy Church in Ideford. We have also been running a Pop-Up Café in St James Teignmouth. Thank you to all the volunteers who give time, effort and skills to these outreach opportunities. These activities require more robust safeguarding oversight and significant time has been spend to ensure that we are demonstrably compliant.

2023/24 will see continued focus on conducting Disclosure and Barring Service checks for all trustees of the church (PCC Members) and key workers or those who help on a regular basis with children's activities. Reg Lake (St Michaels) and Keith Hutchings (Bishopsteignton) are DBS Evidence Verifiers for their individual churches.

We continue to report situations/allegations of concern to the Diocesan Safeguarding Officer (SGO) and we regular seek their advice on many diverse matters. Please continue to report all SG concerns to me your clergy member.

Thank you for your kindness over this past year- and your continued support of the Haldon Mission Community.

Treasurer's Report to the PCC Year Ended 31st December 2022

Financial Review

Our expenditure for 2022 was £60,568 and our receipts as £61,231. Our unrestricted general fund loss was £7,000. Our finances benefited greatly from a single freewill donation of £8,300.

The success of our fund raising for the church, building and roof funds through the Harvest Appeal and other activities, including a raffle for a donated painting of the church by a local artist, raised £10,800. This helped balance our operating deficit and reduced the overall impact on our Financial Assets of the operating loss. The end of year valuation of our investment account has reduced our investment value by £. Regular Giving held firm and Wedding and funeral fees made an important contribution. We have managed down our Church running costs to £10,270.

Our financial figures are reviewed at each PCC meeting. Essentially in 2022, we required about £1,025 per week to cover our costs. Our weekly giving was about £220 per week less than the need. This is a small improvement on 2021.

The common fund assessment or parish share at £33,354 in 2022 is similar to our contribution in 2021 and is based on the band A per capita figure of £620.24 or £11.30 per week. Our assessment uses a participant number of 57. Members need to continue reviewing their level of offering. We are now registered in the Parish Giving scheme, which enables annual increases in line with inflation.

The 100 Club had a successful year and contributed £1615 to our building fund. The roof renewal project fund now stands at £45,000.

In 2018, the PCC transferred £30,000 into the CBF Church of England Investment Fund with a view to this being left in reserve for more than five years. The remainder of our funds are largely available at short notice from our CCLA C of E, Deposit account. We were able to transfer £5,000 back into our deposit account in 2022.

The Treasurer has values greatly the help and support of the Assistant Treasurer. It is a team effort.

Reserves Policy

The PCC continues to maintain an Emergency Fund of £10,000. The monies held in the Tower fund and Building Maintenance fund will not go far in addressing the priority requirements likely to be identified in the next Quinquennial Inspection report, due later this year.
