Reports from Church Organisations

Bellringing

Bellringing has continued to be buoyant and we have been able to ring for the majority of 9.30 and 10.30 services. Choir

The year 2023 proved to be a significant one for the Choir. We moved away from the post-pandemic pattern of occasional appearances for special services on to a much more regular and permanent basis.

In mid-March we reinstated our Friday evening practices and resumed singing at all of the traditional formal Sunday Holy Communion services. Happily, we were back in the choir stalls in time for Easter and the Rev Jane Frost's last few weeks with us.

When the time came for Jane to leave us at the end of April she unfortunately went down with covid so we could not do anything musically special for her here in Bishopsteignton. A few weeks later, however, a Farewell Service for Jane and Richard was held at St Michael's. We joined with the Teignmouth choir members for that service.

The musical highlight of the year was the special Diocese of Exeter Ordination of Priests service at St Michael's in September. There were five ordinands drawn from different parts of the Diocese, including Elizabeth Burren from Teignmouth. The service was led by the Rt Rev Jackie Searle, Bishop of Crediton. We combined with choir members from Teignmouth and Shaldon, making about eighteen of us in all. During the communion we sand anthems by Bach and Elgar. It was an uplifting experience and the service ended with feelings of joy and hope for the future.

The autumn season for us included singing at Harvest Festival and again on Remembrance Sunday. Almost before we knew in, Christmas crept up on us again. We were very busy with carol-singing at Bishopsteignton House, our own Carol Service in church, the late Christmas Eve "Midnight in Bethlehem" service and again on Christmas Day morning. These were all events of great joy and we were very happy to be here keeping our choral tradition alive.

We are a small, friendly group and always welcome enquiries from anyone interested.

Social and Fundraising Report

We are still a team of three, but in 2023 we held or facilated more events than had recently been possible. This was only due to help and support from both St John's church members and some non-church members. Not all events raised actual funds, as the *social* and outreach elements are also part of our brief. Funds raised

by the S&F team are allocated to the restricted Church Building Fund unless otherwise agreed before an event. This covers the fact that we are supported by many non-church members and the team feels that it is fair to everyone to stick to this arrangement for now. **Overall, £2,088 was raised** (£1,198 in 2022) for repairs and maintenance of St John's building. In addition, £68 for the General Fund was achieved via Devon DHCT Coffee Morning.

APCM 3rd May (evening): refreshments were provided and served before and after the meeting to encourage more attendees. This proved reasonably successful.

PLANT SALE 20th May: by kind invitation of Chris Hunt (parishioner) this was held at Stockmeadow House. This was a great success thanks to Bindy for her tremendous "potting on" efforts beforehand. It raised £400.

SUMMER TEA 29th July: this was held in the Community Centre. With thanks to those who supported this lovely afternoon by being waitresses and/or making cakes and to 'The Cream Tea Society' who again supplied the clotted cream and jam, the afternoon raised £340.

DEVON HISTORIC CHURCHES TRUST Coffee Morning 9th September: we hosted this and as mentioned raised £126 for DHTC of which £68 was returned to us.

HARVEST LUNCH 16th September: This was an ecumenical lunch hosted my Mal Worral and her lovely team of helpers in the kitchen (all parishoners). We were only required to wait at tables: Mal did the shopping and all catering tasks. It was intended as a non fund raiser, with the idea that any profit that Mal was able to make should go to a charity of her team's choice. In the event, they chose to donate the £103 profit to St John's repairs for which we were extremely grateful.

CHRISTMAS FAYRE 18th November: This annual event once again proved very popular with church and non-church members. We were pleased to be able to provide a table for Bishopsteignton Scouts who were raising funds for the forthcoming Scout Jamboree. Again with special thanks to the bakers, helpers, donors and punters, the event raised an amazing £720.

SEASONAL CONCERT OF MUSIC AND SPOKEN WORD 18th December: this most enjoyable evening was totally organised by Helen Garrett (parishioner). Helen and the 'Singing for Fun Choir' with friends gave us a real treat of seasonal delights. An estimated 150 people attended resulting in £525 being donated. We owe Helen a big thank you for this 'new' event and hope that it will be repeated sometime.

All these events were made possible by the kindness of volunteers who came forward to help and we would like to say a sincere 'thank you' to them all.

Structure, governance and management

The PCC comprises ex-officio, elected members (there are currently no co-opted members) in accordance with The Church Representation Rules and operates under the Parochial Church Council Powers Measure. It is a *body corporate* established by the Church of England. A 3 year term of office applies to elected members. It is a charity excepted from registration with the Charity Commission.

All church attendees are encouraged to register on the Church Electoral Roll and stand for election to the PCC.

Safeguarding

The Parochial Church Council has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 (duty to have due regard to House of Bishops' guidance on safeguarding children and vulnerable adults). A copy of the church's Safeguarding Policy is displayed on the Notice Board.

Committees

The Fabric Committee, chaired by Mr John Stevenson, with The Church Architects, Benjamin and Beauchamp, manage the major works required to the church. This committee reports directly to the PCC.

Objectives and activities

The Parochial Church Council (PCC) is responsible for co-operating with the Team Rector and the Team Vicar in promoting, within the ecclesiastical Parish, the mission of the Church, pastoral and ecumenical.

Achievements and performance

Church Membership: As at 31st Dec 2023 the Church Electoral Roll stood at 71.

Review of the Year 2023

The PCC held 4 full meetings in 2023, together with shorter meetings following the APCM and a joint meeting of PCCs from across the Haldon Team at St Michael's Teignmouth on 19th September. Average attendance for the 6 meetings was 79%.

The PCC have met the full Common Fund request of £36,492 in 2023. Social & Fund Raising events have continued to be held, and are reported elsewhere in this document.

Treasurer's Report to the PCC Year Ended 31st December 2023

Financial Review

Our expenditure for 2023 was £66,791 and our receipts £44,940. Our income benefitted from over £1000 donated at two community events held in the church. Our church running costs increased by 46% to almost £17,000 in the year. Our unrestricted general fund loss was £21,851 on our day-to-day activities. The end of year valuation of our investment account increased the value of our investment by £5,030. The reduces the apparent operating loss to £16,821. £3,600 was incurred in 2022 and shown as creditors in the 2022 accounts.

The focus of our fund raising for the church, building and roof funds through the Harvest Appeal, 100 Club and other activities helped balance our operating deficit and reduced the overall impact on our Financial Assets to £10,404.

Our financial figures are reviewed at each PCC meeting. Essentially in 2023, we required about £1,280 a week to cover our costs. Our weekly income was about £400 per week less than required.

The common fund assessment or parish share at £36,492 in 2023 and was based on a band A per capita figure of £663.66 or £11.70 per week. Our assessment uses a participant number of 59. We estimate the number of contributing members has fallen through 2023 to 50. However, the parish share for 2024 will be based on £12.67 per week. Members need to review their level of offering. Contributing through the Parish Giving scheme would enable annual increases in line with inflation.

In 2018, the PCC transferred £30,000 into the CBF Church of England Investment Fund with a view to this being left in reserve for more than five years. The remainder of our funds are largely available at short notice from our CCLA C of E, Deposit account. We transferred £10,000 out of our deposit account during 2023 and finished the year with a very much reduced bank balance in our current account.

The Treasurer values greatly the help and support of the Assistant Treasurer. It is a team effort.

Reserves Policy

The PCC continues to maintain an Emergency Fund of £10,000. The monies held in the Tower fund and the Building Maintenance fund (£39,987) will not go far in addressing the priority requirements likely to be identified in the Quinquennial Inspection report just published.

Independent Examiner's Report to the members/trustees of St. John's Church, Bishopsteignton, Parochial Church Council.

Basis of Independent Examiner's Statement


My examination was carried out in accordance with the General Directions given by the Charity Commission.
